Iran's Supreme Court has approved the execution of Sharifah Mohammadi, a syndicate activist and the defender of women's rights, accused of "armed uprising against the government". Although her activities have always been within the framework of the present existing laws in Iran. She is accused only for this reason: she has untiringly defended human rights, women's rights and also the rights of the workers and the toilers.

During her detention, Sharifeh Mohammadi has been deprived of the basic rights of a prisoner such as visitations and telephone contacts. She was deprived of seeing her family for a long time and did not have the permission to have telephone contact with them. She was even prevented from attending her trial and defending herself in the Supreme Court. She is now facing a judiciary apparatus that is determined to sentence her to death for her membership in "Coordinating Committee to Help to Create Workers Organizations".

The syndical organizations, Solitaires, UNSA, CGT, CFDT, and FSU join the actions taken by the International Confederation of the Workers' Syndicates to ask the Iranian Government to

revoke the death sentence for Sharifah and stop all the judicial pursuit against her. This demand includes all syndical activists and other defenders of human rights.

Unfortunately, Sharifah Mohammadi's case is not an exception: from January 1st to September 2nd 2025, more than 863 have been executed of which at least 50 have been executed for their protest and political activities .

The syndical organizations, Solitaires, UNSA, CGT, CFDT, and FSU condemn this horrible trend and use capital punishment as a tool for political oppression. They also severely protest against this negation of the right to live and to live with human dignity. From the time of the month of June 2025 aerial bombardments in Iran by the armies of Israel and the United States, and then the threats of their renewal, the social situation has increasingly deteriorated. The existing government has utilized the war to suppress the opposition and accuse them of being "spies of US or Israel": as an example, it has executed 250 people since June 2025, and on a daily basis heavy sentences have been issued.

Forty second day of hunger strike of 4000 workers of Arak Aluminum

The hunger strike of 4000 workers of the Arak Aluminium Company entered its 42nd day on September 1st, 2025. The workers gathered in the front yard of the factory and demanded immediate consideration of their demands and the removal of the general director and the head of the security of the company.

According to one of the workers' sources, Labour Camp, the workers gathered on a vigil in protest to the neglect by management and spread of falsehood by the Central Province's Labour Bureau. They emphasized that their demands are clear and legal. The implementation of the review of the classification of jobs, on time payment of wages and salaries, replacement of old and worn out equipments by the new ones, implementation of job safety, an end to the pressures by the security people and removal of the main shareholder, who, the workers claim, has the intention of dragging the company into bankruptcy.


This protest is continuing under the condition that the management has filed complaints against the workers and accused them of security violations. The workers have declared that until the fulfillment of their demands, the hunger strike and the vigil in the factory front yard will continue and might eventually spread to outside of the factory.

Iralco workers' protest and hunger strike enters 40th day

The workers announced that they would continue the hunger strike and praise strike in the area until their demands were met, and if the protests continued without explanation, they would take their workers outside the factory.

Workers of the Zahedan district municipality gathered on Wednesday, August 29, 2025, to protest against the five-month delay in their wages. The protesting workers say they have not received their wages for more than five months, despite their appeals. The municipality officials did not reply, and no action was taken to pay the demands.

Week 85th: Expansion of the Tuesdays No to Executions campaign with Sabzevar Prison joining 52 prisons



With a heart filled with sorrow, we are once again witnessing the cruel executions that not only violate the human and legal rights of prisoners, but also wound the conscience of society.

The cruel and inhuman execution of Mehran Bahramian, a political prisoner in Semirom City, not only deprived this person of the right to life, but also lit a fire of anger and protest in the hearts of his family and the honorable people of this city. The honorable protest and strike of the shopkeepers and justice-seeking people of Semirom is a testament to the fact that our people will not remain silent in the face of these crimes and will continue to fight until their rights are realized.

In another criminal act, the reactionary ruling fundamentalist dictator, in silence, hanged two Sunni prisoners of conscience, named Eskandar Bazmandegan and Mohammad Kashefi, in Adel Abad Prison in Shiraz.

Painful statistics show that since the beginning of September 2025, ninety-two prisoners, including four women, have been executed. The death penalty of the regime has claimed the lives of forty-six people in the past week alone. According to statistics, since the beginning of 21st March, 2025, seven hundred and fifty-six people have been executed, of which one hundred were executed in Qezl-e-Hsar Prison. In other words, more than thirteen percent of executions took place in Qezl-e-Hsar Prison. According to news reports, a group of prisoners in Sabzevar Prison have announced that they will join the "No to Execution Tuesdays" campaign starting this week, and will go on a hunger strike every Tuesday in protest of the Islamic regime's wave of executions.

Execution and Repression Must Stop in Iran!

Condemnation of the Death Sentence of

Sharifeh Mohammadi

On the anniversary of the murder of Zhina Amini by the security forces of the Islamic regime, and the uprising of the "Woman, Life, Freedom" movement in Iran, the regime seeks revenge on the most compassionate members of society through various means.

The re-confirmation of the death sentence of Sharifeh Mohammadi — a labour activist and defender of women's rights — is one of the most brutal expressions of this unbridled and relentless revenge.

This sentence against a conscientious and committed activist was upheld by the Supreme Court despite the fact that the legal process in her case was not properly observed. A stubborn judge, acting arbitrarily and without regard for the principles of a fair trial, issued the death sentence, and another judge — in the same political and non-judicial manner — confirmed it under the guise of a "retrial." Yet throughout this entire process, what has been absent is justice, judgment, due process, and a fair trial.

Once again, the confirmation of Sharifeh Mohammadi's death sentence reveals the lack of judicial independence and justice within the regime's apparatus. It shows that this ruling is not merely the product of flawed and contradictory arbitrary laws, but a continuation of ...

Four activists from the Gilan sit-in who participated in Sunday gatherings were arrested

Coordination Council of Iranian Teachers' Guild Organizations The Iranian regime condemns the increasing pressure on social movements (teachers, workers, and pensioners) and warns the government that if this trend continues, it will undermine the existing legitimacy.

September 15, 1404 afternoon, Saturday, the activist of the Evin prison, . Reyhanh Ansarinjad, was released from prison after accepting the usual Judge of the Court of Appeals, and reducing the term of his sentence. Reyhanh Ansarinjad was arrested on 11 May, 2022. Assembly and Collusion with the Intent to Commit Acts Against National Securitytemporarily released on bail of 1.5 billion Toman (US\$15,000/00). Subsequently, Branch 15 of the Court of Appeal sentenced him to four years in prison, a two-year ban on activities in the restricted area and a travel ban; the verdict was also confirmed by the Court of Appeal. Finally, on 06 November 2023 Reyhanhansarinjad was transferred to Naveen Prison to serve the sentence, and on 15 September, after a follow-up and appeal by the judge, Mr. Hossein Tadj, a verdict of release was issued.

She spent more than two years in prison without even a day off, and during this time he was in pain. Despite the urgent need for treatment, he was repeatedly prevented from being sent to the hospital. They even subjected us to the humiliating condition of handcuffing.
